## PLANNING MATTERS

3 Applications

**APP NO:** 13/0471/FUL

**Proposal:** Amendments to previously approved replacement dwelling (11/05866)

including new detached garage to front.

Location: Holly Bush Cottage Whitehall Lane, Little Budworth

Nine members of the public attended the meeting for this item and outside of the formal business of the meeting were allowed to speak to voice their opinions on the application. Members of the council had previously undertaken a site visit. The chairman outlined the planning history to this site and how the the size of the replacement dwelling had increased from c40 sq mtrs (the size of the original dwelling) to c 160 sq mtrs for the proposed replacement dwelling. The council also noted that a number of letters of objection had been received and these objections had also been submitted to the LPA. The council decided to support the residents' concerns and object to the proposal on the grounds that it represents over development on the site, that the dwelling is too large for the site and too close to neighbouring properties.

APP NO: 13/0562/ADV Proposal: 1 fascia sign.

Location: Forest Road Service Station, Forest Road, Little Budworth

The council objects to this proposal on the grounds that it is not in keeping with the local area. The council accepts the need for the business to have signage but not on the scale and extent that already exists.
